- Sexual Health – Emergency Hormonal Contraception
- Smoking Cessation including the use of vapes and varenicline

Additional services that feature within the sexual health service:

- HPV Vaccination Service

Lipid Project

- 6 pharmacies in Benfleet and Rayleigh

Emergency Hormonal Contraception – Southend on Sea

- 6 pharmacies signed up to deliver this service

Although Essex STaRS hold the contract for substance misuse, Healthy Living Partnership is supporting recording, reporting and payments for the services.

Other achievements this year:

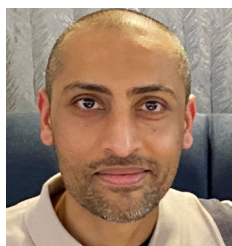

I hope you will join me in making the most of what Healthy Living Partnership can do for your patients and subsequently for us, the contractors as well!

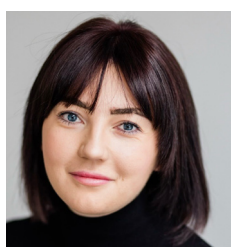

Avi Gami

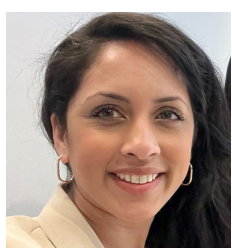

My aim is to make sure contractors have the tools, support, and guidance they need to provide accessible, high-quality care. That means working closely with commissioners and pharmacy teams to plan, launch, and maintain services that really meet the needs of local communities.

I also work as an Operations Lead and Area Manager for an independent pharmacy group, which gives me a real, day-to-day understanding of how things work on the ground. That frontline insight plays a significant role in how I contribute at the board level – ensuring the decisions we make are grounded, practical, and genuinely supportive of pharmacy teams and the patients they care for.



Hema Patel

As a Healthy Living Partnership Director, I have had the privilege of leading initiatives that significantly impact our local community's health and well-being. Our organization plays a vital role in delivering services, including but not limited to, stop smoking programmes, emergency hormonal contraception and NHS health checks through Essex pharmacies.

By providing comprehensive training and materials, such as updated PGDs, access to easy use cholesterol testing and patient resources such as Vapes, we empower pharmacies to effectively offer these local health services.

My involvement has allowed me to engage directly with community members, understanding their needs. The feedback we receive helps us refine our approach, ensuring we not only promote healthier lifestyles but also build a supportive network that encourages sustainable change. Together, we are making significant strides in improving health outcomes across Essex, and I am proud to be part of this transformative journey.

Sexual Health Service

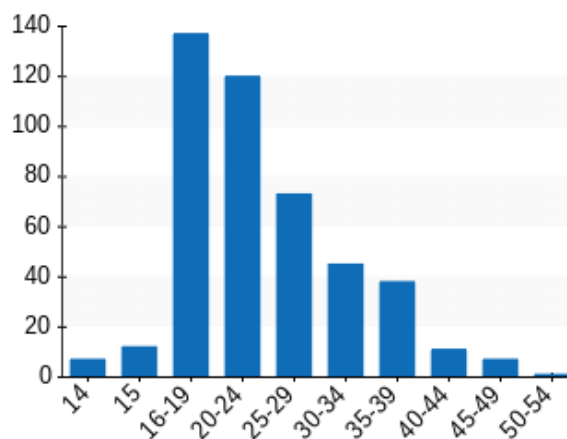
Emergency Contraception Service

Healthy Living Partnership Limited continues to manage the sexual health service in Essex for pharmacies (excluding Southend and Thurrock).

This service covers the provision of emergency hormone contraception (EHC) to women. In December 2024 the upper age limit was removed from the contract, therefore allowing EHC for all ages over 13. As you will see from the age range chart, this has really widened the scope of the service.

With 53 active pharmacy providers there were 451 personal consultations during the year.

In addition to the EHC pharmacies offer, 78 pharmacies have distributed 600 packets of condoms via the Ec-Card scheme, a smartphone app.



HPV Vaccine Service

Even though this service has continued in 9 pharmacies, it appears the demand has decreased, with only 22 vaccines being administered during the year.

Stop Smoking Service

The stop smoking service has been managed by Healthy Living Partnership since 1st July 2024, and we are delighted to see that community pharmacies have already successfully supported 320 people to quit the habit.

Varenicline

Varenicline is again available to assist some quitters, a separate platform features under the stop smoking service on PharmOutcomes, as well as including a copy of the PGD.

Pharmacists and registered Technicians have been enrolling for Varenicline dispensing on PharmOutcomes. It is expected that all pharmacies, delivering the stop smoking service, will also supply Varenicline.

The most popular NRT supplied are the patches, but there has been a noticeable increase with quitters using vapes to support their aid to stop smoking

Vapes

Many pharmacies are now offering Tornado GTL VAPES as a successful pathway to quit smoking.

One Pharmacy in Essex has feedback that vapes have taken off very quickly at the pharmacy with a number of quits as a result of using this method. It has become popular due to the pharmacy actively promoting the Quit Smoking Programme with free vapes promotion on Facebook. Together with word of mouth promotion through school mums and other community chats, this has resulted in a very enthusiastic uptake and successful quits.

Cut down to Stop (CDTS)

This is a 4 week reduce to quit pathway leading up to the 8 weeks not a puff programme. Healthy Living Partnership Limited is encouraging pharmacies to offer this new pathway for those requiring a little time to adjust and practice using products.

NHS Health Checks

Similar to the stop smoking service, Healthy Living Partnership Limited has also managed the pharmacy providers for the NHS Health Checks since July 2024.

Data extracted from PharmOutcomes shows between 1st July 2024 and 31st March 2025 shows 638 members of public had a NHS Health check in a 34 pharmacy settings.

With exciting news, Healthy Living Partnership and Community Pharmacy Essex (LPC) commission PocDoc as technology partner to deliver health checks across Essex to reduce the prevalence of cardiovascular disease across the UK.

PocDoc cholesterol kits can be used as part of the NHS Health Check service, it only takes 7 minutes for the result. During this time, it gives an opportunity to discuss other issues about the health check, but also other lifestyle matters, maybe stop smoking.

Data from PharmOutcomes show 319 cases where brief advice was given on reducing cholesterol and 15 were referred to a GP.

Supervised Consumption Service

Essex STaRS hold the contract for the Supervised Consumption Service, however Healthy Living Partnership is supporting recording, reporting and payments for the services.

According to PharmOutcomes data, there have been 378 registered users, at 42 community providers. Nearly 3000 personal provisions.

Southend Sexual Health Service

Southend-on-Sea City Council commission community pharmacies for the provision of emergency hormonal contraception (EHC), to facilitate the delivery of services within local communities and closer to the places people live and work.

The pharmacy EHC service supports the important role community pharmacy teams can play to help address health inequalities by providing wider healthcare access in their communities and signposting service users to local sexual health services. It also aims to create additional capacity in primary care and sexual health clinics (or equivalent) to support meeting the demand for more complex assessments.

Working with the Healthy Living Partnership to promote sign up to this contract, and increase delivery in community pharmacies, has been a key objective in 2024/25. During this time, there has been a marked increase in delivery, with monthly consultations increasing from an average of 7 consultations per month in quarter 1, to an average of 17 in quarter 4, with some months seeing as high as 28 consultations.

There are currently 6 pharmacies who have signed up to deliver this service, and 4 are active providers, having made 198 personal consultations during the year.

Mid and South Essex Palliative Care Services

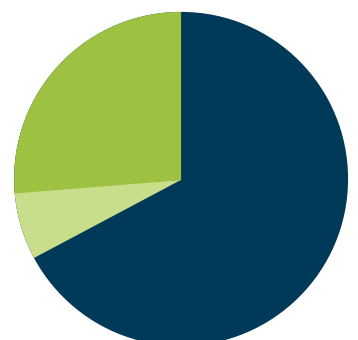
Nine services across Mid and South Essex continue to hold specialist palliative care medication and supply on receipt of a prescription.

Healthy Living Partnership was also activity involved with other events, here are a flavour of some of them.

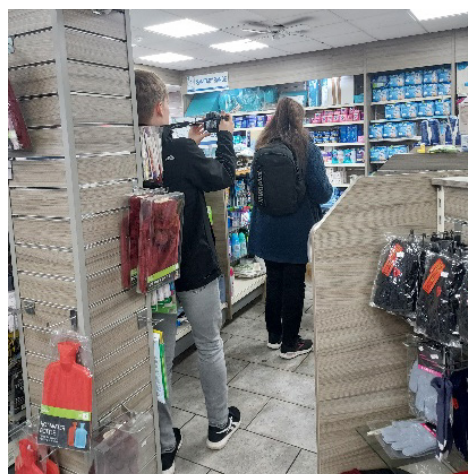
Healthwatch Day

Karen Samuel-Smith, Chief Officer at Community Pharmacy Essex gave an update on some of the challenges local pharmacies face, ranging from financial and supply chain issues to the struggle to recruit and retain staff at the Healthwatch event on 10th April 2024. She also spoke about some of the opportunities on offer, such as Pharmacy First.

Wow, thank you so much for attending today's forum meeting, we think it was one of the best ones we've had! We are incredibly appreciative of your responses, the knowledge you shared and how keen you were to hear from the forum members. I have spoken to a few of the forum members too and they are really happy with how it went and felt like they learnt a lot.

Following on from this event, Community Pharmacy Essex commissioned Healthy Living Partnership Limited to produce resources. A video was produced around accessibility. It involves volunteers who are sensory impaired or living with learning disabilities. This can be shared with pharmacies.

Filming took place at Asif Pharmacy in October 2024.

Lipids Management Service

6 pharmacies in Benfleet and Rayleigh were involved with the Lipids Management Service. Each community pharmacy premises, upon receipt of a signed agreement to the Memorandum of Understanding, was eligible to receive a payment for completing Very Brief Advice checklists (minimum 50 records per month). This project was funded by an external grant to tackle health and inequalities.

Essex County Council – Healthy Living Pharmacy Launch event

Community Pharmacy Essex and Healthy Living Partnership Ltd have been working with Essex County Council to develop an exciting new way of promoting and delivering local services. And a launch event took place on 12th June at County Hotel, Chelmsford.

Each participating pharmacy will be eligible for a payment of £250.00 per month for up to three years to support the health champion role.



Pharmacies participating as Healthy Living Pharmacy Level 2/3 need to:

- Meet all the criteria for Healthy Living Pharmacy level 1 outlined in the Community Pharmacy Contractual Framework
- Actively provide or be willing to provide all the services commissioned by Essex County Council:
- Services to support substance misusers including supervised consumption, needle exchange and naloxone supply
- Support to help smokers to quit (new service specification for 2024)
- NHS Healthchecks
- Locally-commissioned sexual health services.
- Actively provide the following Community Pharmacy Contractual Framework advanced services:
 - NHS Hypertension case-finding advanced service
 - NHS Pharmacy contraception service

Within the first month of launching the programme, 13 pharmacies were recruited and since then 28 pharmacies are now participating. Thanks to Lisa Lovell for project leading this.

More details can be found later in the report from Lisa Lovell.

Southend Sexual Health

Brook in Southend hosted an event for Southend pharmacies in November 2024 and looked at the business case for integrating the emergency contraception local commissioned service with the NHS Pharmacy Contraception Service, developing technicians to work to EHC PGDs and Southend safeguarding issues.

It was also a great opportunity for pharmacy teams to see the new facilities at the Brook clinic, and find out more about the specialist services available there.

Contractor development day on 9th February 2025

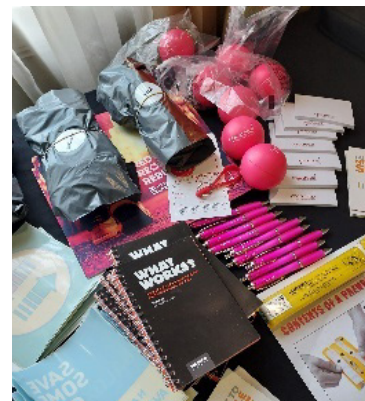
Healthy Living Partnership Limited and Community Pharmacy Essex hosted the Contractor Development day on Sunday 9th February 2025. We welcomed approximately 70 contractors to share, learn and connect with colleagues at the training conference.

It was fantastic to have trainers and local providers to update and provide sessions for our contractors ranging from GPhC, optimising service income, addressing vaccine hesitancy.

The Mental Health First Aid training, delivered by Lyn Mowforth from Provide CIC, was incredibly popular. We had originally worried that we wouldn't meet the minimum number for training and would face charges for empty places, but ended up heavily over-subscribed.

We also had well-received workshops led by Gemma and David from GPhC and Jane Newman, our Controlled Drug Accountable Officer on current themes in GPhC inspections and controlled drugs, Principles of Vaccination and Addressing Vaccine Hesitancy from Jansher Khan from MSD, Stop Smoking refresher and the Varenicline PGD from Lisa Lovell, and maximising service income from Liam Stapleton who presented live virtually.

Thanks to all those involved, the events was a resounding success!



Healthy Living Partnership Board Meetings

The Directors have met four times during the year to discuss commissioned services, review the benefits of them to the community and whether pharmacy teams are experiencing difficulties, recognizing their achievements and discussing forward thinking ideas of new services and initiatives.

Initiatives

Needle Exchange Training

During February 2025, Healthy Living Partnership encouraged pharmacy team members to upskill their knowledge and understanding on the needle exchange programme. 10 pharmacies successfully rose to the challenge, and 36 team members received a £10 gift voucher for completing the training.

March into March

Pharmacy Teams have put so much effort into developing and promoting healthy lifestyles services and advice, and in March 2025 Healthy Living Partnership encouraged them to put a bit of this into practice!

Pharmacies were challenged to become more active during March and we are really pleased to announce the winners. The THREE categories were:

- Team with the highest AVERAGE steps – Colchester City Pharmacy
- Team with the biggest IMPROVEMENT from start of the month to the end of the month – Sandra Weathersbee from Sach Chemist in Pitsea
- Individual with the HIGHEST NUMBER of steps overall Mandy Langdell from Easter Pharmacy in Buckhurst Hill.

Pharmacy teams were awarded prizes to the deserved winners.

Thanks to all the pharmacies that joined in.



The Office team also joined in with the challenge and achieved an average of 237,354 steps between 3 team members.

Essex County Council, Healthy Living Pharmacy Level 2/3 by Lisa Lovell

28 pharmacies are now actively participating in the Essex County Council Healthy Living Pharmacy programme and showing some great results and successes.

PharmOutcomes shows the Stop Smoking conversion rate as 66% quits achieved for 2024-2025. 320 quits from 483 sign ups overall.

22 of the healthy living pharmacy participating pharmacy providers achieved 130 of these quits.



Varenicline

Varenicline was re-introduced at the beginning of the year which has shown to be popular and already we have seen successes with this medication.

At the end of March 2025 42 varenicline enrolments by pharmacies. All pharmacies within this group had enrolled.

Vapes

20 pharmacies have attended Vape webinars and now have vape provision. 15 of these pharmacies are from the participating pharmacies and showing an increase in the number of quits.

NHS Health checks

A total of 638 health checks have been completed during 2024–2025. Over 400 opportunistic and 207 referral from GPs or from Provide via GPs.

34 pharmacies are actively delivering in this service, and 426 of these health checks have been completed by the participating pharmacies.



Emergency Contraception

451 emergency consultations have occurred during 2024–2025. 237 of these have occurred within the participating pharmacies group

Supervised Consumption Service

All the participating pharmacies have signed up to deliver the supervised consumption services via Essex STaRS and in total 414 clients have registered.

215 of these clients have been registered within this group.

Needle Exchange

Pharmacies have completed Needle Exchange training and a number are awaiting Open Road initiation.

Health Champions Level 3

Pharmacies have a trained health champion, are working through the course or have registered for the June intake.



Monthly Meetings

Regular attendance at monthly meetings has been well received with more lifestyle conversation training requested and stop smoking Q and As.

Fantastic effort from all the participating pharmacies. With good team work, facebook and verbal promotion, you are really making a difference to the local community.

Notes to the Financial Statements for the Year Ended 31 May 2024

1. STATUTORY INFORMATION

Healthy Living Partnership Limited is a private company, limited by shares, registered in England and Wales. The company's registered number and registered office address can be found on the Company Information page.

The company is not part of a group.

2. ACCOUNTING POLICIES

Basis of preparing the financial statements

These financial statements have been prepared in accordance with Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" including the provisions of Section 1A "Small Entities" and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Turnover

Turnover represents invoiced sales of services and membership fees received. The company is not VAT registered.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Plant and machinery etc – 33% on cost and 20% on reducing balance.

Financial instruments

The company only enters into basic financial instrument transactions that result in the recognition of financial assets and liabilities like trade and other debtors and creditors and investments in ordinary shares.

Taxation

Taxation for the year comprises current and deferred tax. Tax is recognised in the Income Statement, except to the extent that it relates to items recognised in other comprehensive income or directly in equity.

Current or deferred taxation assets and liabilities are not discounted.

Current tax is recognised at the amount of tax payable using the tax rates and laws that have been enacted or substantively enacted by the balance sheet date.

Deferred tax

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.

Timing differences arise from the inclusion of income and expenses in tax assessments in periods different from those in which they are recognised in financial statements. Deferred tax is measured using tax rates and laws that have been enacted or substantively enacted by the year end and that are expected to apply to the reversal of the timing difference.

Unrelieved tax losses and other deferred tax assets are recognised only to the extent that it is probable that they will be recovered against the reversal of deferred tax liabilities or other future taxable profits.

Significant judgements and estimates

No significant judgements or estimations have been applied in the preparation of the financial statements.

Debtors

Short term debtors are measured at transaction price, less any impairment.

Creditors

Short term creditors are measured at the transaction price.

Welcome and Introductions

Ani Patel opened the AGM but acknowledging all the work Bharat Patel had achieved with the Healthy Living Partnership prior to his appointment to Chair.

Ani introduced Natasha Jones and Ashok Pattani who were present, unfortunately 2 other Directors were not able to attend, Hema Patel and Avi Gami.

Concept of Healthy Living Partnership

He explained that Healthy Living Partnership Limited was created as a provider company to secure funding for contractors through locally commissioning services, as this is not feasible within the LPC constitution.

The mission statement for Healthy Living Partnership is *"For Contractors with Commissioners for Patients"*.

As an example Healthy Living Partnership have been able to secure PocDoc in supplying cholesterol test lateral flow kits for pharmacies delivering health checks, with the potential of getting £45 in return from health checks and blood pressure checks.

Annual Report and Financial Report 2023–2024

The Healthy Living Partnership annual report has already been distributed to all Essex Contractors, however Ani summarised its contents. He also added if your pharmacy has already signed up to deliver a service, ensure you execute, delivery and report the data.

Ani asked if all in attendance was satisfied with the accounts included in the report. It was unanimously approved.
